iii. Incorporation of provisos under Statutes 12.1, 12.10.1 and 16.1.1 of the Statutes governing affiliation of colleges and other institutions. The provisos shall be placed under the existing aforementioned Statutes in **Chapter-IV, Vol-I** of the University Calendar, as approved by the University Council vide **Resolution No. 81.15** which reads as under:

12.1	The Government/Society/ Trust which proposes to start the college within the territorial jurisdiction of the University of Jammu and wishes to get it affiliated to the University of Jammu, shall submit an application for grant of affiliation to new college/ institution which should reach the Director, College Development Council, by October 1 st of the year preceding the one in which it is proposed to hold admissions and start the class work, in the prescribed proforma alongwith the prescribed fee in the form of demand draft drawn in favour of the Registrar, University of Jammu.	Provided that if an Educational Agency having been permitted by the State Government to establish a new College/Institution, applies for grant of affiliation to the said new college/institution after the prescribed cut of date (i.e. October 1 st of the year preceding the one in which it is proposed to hold admissions and start the class work), the affiliation form will be entertained provisionally subject to payment of prescribed late fee upto <u>31st of March</u> . The college shall be inspected but affiliation shall be granted, subject to recommendations of the Inspection Committee, upon production of permission of the State Government and approval of appropriate regulatory/ statutory authority, if applicable, by 10 th May of the year in which the college intends to hold admissions. In no case this date shall be extended.
12.10.1	Application for extension/renewal of temporary affiliation alongwith prescribed application and /or inspection fee must reach the Director, College Development Council, alongwith requisite inspection fee by 31 st December of the preceding year for which extension/renewal of affiliation is sought.	Provided that if the college applies for renewal/extension of its temporary affiliation upto 31 st December of the preceding year, the form be provisionally entertained and inspection for extension/renewal of temporary affiliation be authorized to be completed. 16.1.1	Each institution applying for permission /affiliation in new subject(s) shall remit non-refundable prescribed application fee at the time of issue of Application Form. Thereafter, the institution shall remit prescribed inspection fee per subject per course (when asked to do so) before the inspection of the college is conducted. The Application Form, duly filled, alongwith the requisite documents shall be sent to the Director, College Development Council, so as to reach him by October 1 st of the year preceding the one in which the subject(s) is/are proposed to be introduced. Provided that, the Vice-Chancellor may, in special circumstances, authorize entertainment of an Application Form submitted after October 1 st but in no case form be entertained after 31 st March. Provided further that, no college/institution shall start teaching new subject(s) without prior permission of the University.	Provided that if the college applies upto due date alongwith permission of the State Government, the form be provisionally entertained and inspection for grant of affiliation in new subject/stream be authorized. However, if the college fails to submit renewed permission of the State Government and approval of the concerned Central Regulatory Authority for the relevant session before 10 th May of the year in which the college intends to start academic session/class work in new subject/stream, affiliation may not be granted and the college has to apply afresh for the succeeding session.

- iv. Amendment in the Statutes for admission to various academic programmes for the session 2016 as given in **Annexure-I** which shall be incorporated in JUET Brochure and **Chapter-XVI, Vol-I** of the University Calendar, as approved by the University Council vide **Resolution No. 81.19**.
- v. Modification in the eligibility condition for the post of Scientific Officer in the University Science Instrumentation Centre(USIC)which shall be incorporated in **Chapter-XXXVII-C, Vol-I** of the University Calendar, as approved by the University Council vide **Resolution No. 81.23**, which reads as under:

- vi. Amendment in Statute 2 of the Statutes governing the Two Year B.Ed. course which shall be incorporated in **Chapter-XLIV, Vol-II** of the University Calendar, as approved by the University Council vide **Resolution No. 81.30**, which reads as under:

Admission to B.Ed. course in Colleges of Education, other than the Govt College of Education, in and offsite campuses of the University shall be open to those candidates who have passed Bachelor Degree examination with 50% aggregate marks for the General Category and 45% marks for Reserved Categories of SC/ST and Others as per the rules of the State Govt. in the Faculties of Arts. Science. Social Sciences. Commerce or Faculty of Music and Fine Arts, conducted by the University of Jammu or an examination of any other University recognized as equivalent thereto or Bachelor's degree examination of four years duration in a recognized University.	Admission shall be open to those candidates who have passed Bachelor Degree (10+2+3 pattern) and/or Master's Degree with 50% aggregate marks (45% marks for SC/ST candidates in the Faculties of Arts. Science. Social Sciences. Commerce or Faculty of Music and Fine Arts, conducted by the University of Jammu or an examination of any other University recognized as equivalent thereto or Bachelor's Degree examination of four year duration in a recognized University.

- vii. Prescription of application fee and inspection fee to be charged from the Degree Colleges affiliated to the University of Jammu for grant of affiliation in a new stream which shall be incorporated in **Chapter-LXXIV, Appendix-III, Vol-II** of the University Calendar, as approved

by the University Council vide **Resolution No. 81.33**, which reads as under:

"If the existing Degree Colleges intend to start a new stream, the fee structure would be as under:-

- i) Application fee : Rs.10,000/-
- ii) Inspection fee : Rs.20,000/-

However, if a Degree College wants to introduce new subject/s in the existing stream, the fee already notified shall be applicable."

However, the Application fee for introduction of a new stream in the case of Govt. Degree Colleges shall be Rs. 2500/-."

Further, the aforesaid cutoff marks maybe lowered down by 5% by the Vice-Chancellor on the recommendation of the Admission Committee of the Concerned Department/s in case of more than 50% of seats remain vacant.
5. There shall be two question papers for JUET-2015, one for the candidates seeking admission to Under Graduate Programme and the other for the candidates seeking admission to the Post Graduate Programme.
6. The level of numerical ability shall be of 10th standard only for both the question papers.
7. The level of test for other components shall be of 12th standard in case of candidates appearing after 12th class and graduation standard for the candidates appearing after graduation.
