Subject: UNIVERSITY REGULATIONS

It is notified that the **76th University Council** approved the following at its meeting held on **15th April, 2014** at Raj Bhavan, Jammu:-

- I. *Amendment in the following Regulations governing Jammu University Entrance Test for admission to the various academic programmes of the University/Offsite Campuses/Private Affiliated Colleges from the academic session 2014-15 shall be replaced with the existing Regulations in **Chapter-XVI** of University Calendar, 2010, (Vol-I) (Resolution No. **76.20**):*

<p>i) Admission to the PG Departments of the University of Jammu, Jammu / Campuses / Affiliated Colleges shall be made on the basis of Entrance Test and Academic Merit of Qualifying Examination. The final merit of a candidate out of 100 shall be calculated by giving a weightage of 40 i.e. marks obtained in the Entrance Test and a weightage of 60 to the percentage of marks obtained in the qualifying examination- the 60 shall be calculated by giving the weightage of 20% each to the percentage of marks in Part I, II & III separately.</p>	<p>i) Admission to the PG Departments of the University of Jammu, Jammu / Campuses / Affiliated Colleges shall be made on the basis of Entrance Test and Academic Merit of Qualifying Examination. The final merit of a candidate out of 100 shall be calculated by giving a weightage of 40 i.e. marks obtained in the Entrance Test and a weightage of 60 to the percentage of marks obtained in the qualifying examination- the 60 shall be calculated by giving the weightage of 20 each to the percentage of marks in Part I, II & III separately.</p> <p>The relative positive score of each candidate subject wise shall be taken into consideration for calculating final merit of the candidate. The relative score of the candidate shall be calculated as per the following formula:</p> <p><u>Marks obtained by the candidate in the Entrance Test</u> X 40 Maximum marks obtained in that subject</p> <p>To qualify the Entrance Test the candidate is required to obtain a minimum relative score of 14 out of 40 for general category candidates and a relative score of 12 out of 40 for candidates belonging to SC/ST/ST (residents of Leh & Kargil) category.</p>
