

Jammu, the 26<sup>th</sup> December, 2017**

**SR0525** In exercise of the powers conferred by proviso to section 124 of the Constitution of Jammu and Kashmir, the Governor is hereby pleased to make the following amendment in the Jammu and Kashmir Government Employees Conduct Rules, 1971;

after sub-rule(3) of rule 13, the following shall be added as sub-rule (4), namely:-

"4. No Government employee shall engage in any criminal, dishonest, immoral or notoriously disgraceful conduct on social media which may be prejudicial to the Government. They shall also not use their personal social media accounts for any political activity or endorse the posts or tweets or blogs of any political figure and also shall not use their accounts in a manner that could reasonably be construed to imply that the Government endorses or sanctions their personal activities in any matter whatsoever. They shall also not post inflammatory, extraneous messages in an online community with the intent of provoking readers into an emotional response or of otherwise disrupting normal, on topic discussion".
