Based on the recommendations made by the Central Purchase Committee at its meeting held on 28-06-2016 vide Resolution No. 01, the Vice-Chancellor is pleased to approve the lowest competitive rates for Refilling and Recharging of Toners offered by the firms, **as detailed in the Annexure which is available in the Jammu University website www.jammuuniversity.in**, for the current financial year 2016-17, alongwith following terms and conditions:

1. The supplier/s should give an affidavit that the concerned firms are intact till date and not working as casual traders.
2. The supplier/s should be bound to make the supply within the stipulated time period as given in the supply order on the basis of the rates approved by the University failing which the firm/s be debarred for the next three years to enter in the University business alongwith 10% amount of the CDR submitted by the firm/dealer/s be deducted as a part of penalty".
3. In case of failure of the supply to whom the order has been placed, the rates of the second highest from the lowest tenderer also be approved to supply the same article/items on the basis of lowest rates quoted by the firm.
