## ORDER

**Reference: - 81<sup>st</sup> University Council Meeting Resolution Nos. 3.14.3, 3.14.4 and 3.14.5.**

Pursuant to the University Council Resolution Nos. 3.14.3, 3.14.4 and 3.14.5 as passed at its 81<sup>st</sup> University Council meeting held on 20.10.2016, sanction is hereby accorded to the creation of post of Dean, Planning and Development in the University of Jammu, Jammu on the terms and conditions as are applicable to the position of the Dean Academic Affairs. The position of the Dean, Planning and Development shall be at par with the positions of the Dean Academic Affairs and Dean Research Studies. The tenure of the position shall be for a period of two years extendable by one year, which shall be filled up from amongst the senior Professors, with the powers and functions enumerated as under:

1. To plan a road map for the future development of the University.
2. To devise policy on the expansion and diversification of the University activities.
3. To monitor the physical targets and utilization of funds with respect to the developmental projects funded by the State and the Central governments and the other agencies/institutions.
4. To prepare relevant papers for submission of progress reports of the developmental projects to the various funding agencies.
5. To prepare proposal for the development of the main and the offsite campuses.
6. To plan and prepare the strategic plan for the University and fixing priorities of the various works.
7. To review various proposals for initiation of new programme and courses of study in terms of their viability, job requirement and feasibility.
8. To enhance coordination with regard to the developmental projects, between the main and the offsite campuses.
9. To liaise with the various funding agencies and to keep track of the various Schemes announced by the Government agencies for the funding of the infrastructural projects.

Further, the office of the Dean, Planning and Development shall ensure that the developmental planning is in tandem with the academic and other relevant requirement of the University.

The Dean, Planning and Development shall report to the Vice-Chancellor and assist him regarding the planning and development issues of the University as enumerated above.
