O R D E R

Whereas, the Higher Education Department, J&K vide No.HE/Recog./B.Ed/J/NGM/56/2001 dated 08.03.2001 issued No Objection Certificate for setting up New Gandhi Memorial College of Education, Miran Sahib, Jammu by New Gandhi Memorial Educational Society, Miran Sahib, R.S. Pura, Jammu for imparting instructions in B.Ed. course, in pursuance whereof the college was granted temporary affiliation for the session 2001-02 vide No.CDC/2001/6301-66 dated 28.12.2001, which temporary affiliation was being extended by the University of Jammu on year to year basis;

Whereas, the Chairman vide letter No. NGM/B.Ed/10588 dated 07.09.2015 refused to make admission for the session 2015-17;

Whereas, the request of the Chairman was referred to the committee already constituted vide order No.CDC/2015/3500-08 dated 11.08.2015 for dealing with the situation where a college refuses to make admission during the process of admission and other allied aspects;

Whereas, the Committee held its meeting on 23.09.2015 and after thorough discussion recommended that a show-cause notice be issued to the Chairman, New Gandhi Memorial College of Education, as to why the following actions be not taken:

1. Forfeiture of endowment fund.
2. Disaffiliation of the college.

Whereas, the aforesaid recommendations of the Committee met the approval of the competent authority in pursuance whereof a show-cause notice was served upon the College vide No.CDC/2015/5307-08 dated 28.10.2015 which was responded by the college vide letter No. NGM/B.Ed/10609 dated 09.11.2015;

Whereas, the aforesaid committee in its meeting held on 15.01.2016 considered the reply of the college dated 09.11.2015 and, inter alia, recommended as under:

1. Endowment Fund created by the NGM College be forfeited and proceeds deposited under the appropriate head of the University.
2. NGM College be disaffiliated for three years.

Whereas, the aforesaid recommendations of the Committee were considered by the competent authority and same stands approved.
